5. Late Declaration Fee

Late Declaration Fee (VAT 0%)
<p>If a company submits the declaration form after the deadline, the company will be invoiced a late declaration fee per declaration form.</p>
<p>The amount of the fee, if the declaration is submitted with a maximum of one month delay</p> <ul style="list-style-type: none">• 1 % of the recycling fees or SUP fee declared by the company.• A company that reports data once a year: The fee is at least 20 € and a maximum of 5000 € per late declaration form.• A company that reports data quarterly: The fee is at least 5 € and a maximum of 1250 € per late declaration form.
<p>If the declaration form is submitted with a delay of over one month, but no more that two months delay from the deadline, the above fee is doubled.</p>
<p>If the declaration form is submitted with a delay of over two months from the deadline, the fee is tripled.</p>
<p>If the reporting is delayed with over three months from the deadline for reporting, Rinki invoices, in addition to the late declaration fees, also an estimate of the EPR fees based on the packaging data available to Rinki.</p>
